Now I, the said Charles Neve Cresswell, do hereby, in pursuance of the said Warrant of Appointment, determine, as hereinafter mentioned,

the boundaries of the six wards into which the said borough shall be divided, which wards are hereinafter numbered and named as follows, that is to say :--

Ward No. 1, otherwise Northgate Ward. Ward No. 2, otherwise Eastgate Ward. Ward No. 3, otherwise Southgate Ward. Ward No. 4, otherwise Westgate Ward. Ward No. 5, otherwise Risbygate Ward.

Ward No. 6, otherwise Abbeygate Ward.
