GENERAL ORDER of the Local Government Board : Election of Guardians : Altering Orders as to dates for certain proceedings:-

To the Guardians of the Poor of the several Unions and Separate Parishes hereinafter referred to ;-

And to all others whom it may concern.

WHEREAS by certain General Orders dated the 14th day of February, 1877, and the 29th day of October, 1881, and by certain other Orders, We, the Local Government Board, prescribed regulations relating to the Election of Guardians of the Poor in the Unions and Separate Parishes hereinafter referred to, and, amongst other things, made provision with regard to the dates on which the several proceedings in the-Election should take place;

And whereas it is expedient that certain otherprovision should be made on the subject as hereinafter mentioned:

Now therefore, in pursuance of the powers given to Us by the Statutes in that behalf, Wehereby Order as follows :-

ARTICLE 1 .- Notwithstanding anything contained in the General or other Orders above referred to, in the event of a contest at the annual or triennial election in the current year of Guardians of the Poor in any of the said Unions. and Separate Parishes, the several hereundermentioned proceedings in the Election shall takeplace on the following days; that is to say,—
The voting papers shall be delivered to the

voters on the 10th day of April, 1890.
