

The voting papers shall be collected on the 11th day of April, 1890.

Voting papers may be applied for, if there should be a default of delivery, on the 11th day of April, 1890, or before noon on the 12th day of April, 1890.

Voting papers may be delivered to the Returning Officer, if there should be a default in the collection, before noon on the 12th day of April, 1890.

The casting up of the votes shall commence on the 12th day of April, 1890.

ARTICLE 2.—The Returning Officer shall make his Certificate with respect to the Election on the 12th day of April, 1890, or as soon after such date as may be practicable.

ARTICLE 3.—The Unions and Separate Parishes herein referred to are those of the Unions and Separate Parishes named in the Schedules to the above-cited General Order of the Twenty-ninth day of October, one thousand eight hundred and eighty-one, in which an annual or triennial Election of Guardians will take place in the current year; and also any new Union to which the provisions of the above-cited General Orders may have been or may be applied for the purpose of an Election of Guardians in the months of March and April in the current year.

(SWINE-FEVER.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Area (namely),—the parish of Bulwell, in the borough of Nottingham,—which was declared by Order of the Board dated the thirty-first day of October, one thousand eight hundred and eighty-nine, to be an Area infected with swine-fever, is hereby declared to be free from swine-fever, and that Area shall, as from the commencement of this Order, cease to be an Area infected with swine-fever.

2. This Order shall take effect from and immediately after the ninth day of February, one thousand eight hundred and ninety.

(PLEURO-PNEUMONIA.)

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under

The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The limits of the following Place which is declared by order of the Local Authority for the county of Middlesex, dated the thirty-first day of January, one thousand eight hundred and ninety, to be a Place infected with pleuro-pneumonia (namely),—the whole of the premises known as the Model Farm, Hendon, in the occupation of Messrs. William Flux and Son, and the whole of the adjoining farm premises and cow-sheds at Hendon, in the occupation of Mr. Frederick Hinge,—are hereby extended so as to include the Place described in the Schedule to this Order; and the Place described in the Schedule to this Order is hereby declared to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the tenth day of February, one thousand eight hundred and ninety.

THE RABIES (MUZZLING OF DOGS) ORDER OF 1889, AMENDMENT.

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The Rabies (Muzzling of Dogs) Order of 1889 (in this Order referred to as the Muzzling Order) is hereby amended as follows:

Exclusion of Districts from Muzzling Order.

The provisions of the Muzzling Order shall not apply to the following District and part of District (namely):

Borough of Barrow-in-Furness.

So much of the county of Lancaster as is comprised in the Hundred of Lonsdale North of the Sands, in that county.

and the Muzzling Order shall be read and have effect as if that District and part of District were not included in the Schedule to that Order.

2. This Order may be cited as The Rabies (Muzzling of Dogs) Order of 1889, Amendment.
