and as between the rector of the benefice of Saint Margaret Lee and his successors on the one hand and the incumbent of the said benefice of the Good Shepherd, Lee, and his successors on the other hand as if the same benefice of the Good Shepherd, Lee, and the incumbent thereof had been named in the said deed instead of the benefice of Christ Church Lee Park and the incumbent

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act of Parlia-

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of C. L. Peel. Rochester.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirtyfour; of the Act of the second and third years of Her Majesty, chapter forty-nine; of the Act of the third and fourth years of Her Majesty, chapter sixty; and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council a representation, bearing date the sixth day of February, in the year one thousand eight hundred and ninety, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England in pursuance of the Act of the fiftyninth year of His Majesty King George the Third, chapter one hundred and thirty-four, of the Act of the second and third years of Your Majesty chapter forty-nine of the Act of the third and fourth years of Your Majesty chapter sixty and of the Act of the nineteenth and twentieth years of Your Majesty, chapter fifty-five have prepared and now humbly lay before Your Majesty in Council, the following representation as to the assignment of a district chapelry to the consecrated church of the Lady Margaret situate in Chatham-street in the new parish (sometime district chapelry) of Saint John Walworth in the county of Surrey and in the diocese of Rochester.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of the Lady Margaret situate as aforesaid.

"Now therefore with the consent of the Right Reverend Anthony Wilson, Bishop of the said diocese of Rochester (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all

Walworth, which is described in the schedule hereunder written, all which part, together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of the Lady Margaret situate as aforesaid and that the same should be named 'The District Chapelry of the Lady Margaret, Walworth.

"And with the like consent of the said Anthony Wilson Bishop of the said diocese of Rochester (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of the Lady Margaret situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always that so long as the Reverend George Toulson Cotham, Clerk in Holy Orders the present vicar or incumbent of the vicarage of the said new parish of Saint John Walworth shall continue to be such vicar or incumbent all the fees and offerings which may be received in respect of such publication solemnization or performance at the said church of the Lady Margaret situate as aforesaid shall be paid over by the Minister thereof to the said George Toulson Cotham and provided also that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the performance of the said office of baptism or for the registration thereof.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of the Lady Margaret, Walworth, being :-

"All that part of the new parish (sometime district chapelry) of Saint John, Walworth, in the county of Surrey, and in the diocese of Rochester, which is bounded upon the north-east by the new parish of Saint Mary, Southwark, upon the south-east by the new parish of All Saints, Newington, upon part of the south-west by the new parish of Saint Mark, East-street, Walworth, all in the county and diocese aforesaid, and upon all other sides, that is to say, upon the remaining part of the south-west and upon the north-west by an imaginary line commencing upon the boundary which divides the said new parish of Saint Mark, East-street, Walworth, from the new parish of Saint John, Walworth aforesaid, at the point where Rodney-road is joined by Orb-street by Wadding-street, and by the street called or known as Salisbury-row, and extending thence north-westward along the middle of the said Rodney-road for a distance of ten chains or thereabouts to its junction with the street called or known as Victory-place, and extending thence north-eastward along the middle of the last-named street for a distance of fourteen and a half chains or thereabouts to the boundary which divides the said new parish of Saint John, Walworth, from the new parish of Saint Mary, Southwark aforesaid."

And whereas the said representation has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in that part of the said new parish of Saint John, law immediately from and after the time when
