They will be dated the 5th April, 1890, and will be payable at three months, or six months, or twelve months after date, at the option of the persons tendering, viz. :— on the 5th July, or 5th October next, or 5th April, 1891, respectively.

4. The Bills will be issued and paid at the Bank of England.

5. The persons whose Tenders are accepted will be informed of the same on Tuesday, the 1st proximo, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England not later than two o'clock, on Saturday, the 5th proximo.
