(SWINE-FEVER.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The following Area (namely),—the whole of the parish of Herbrandstone, in the county of Pembroke,—which was declared by Order of the Board dated the twelfth day of March, one thousand eight hundred and ninety, to be an Area infected with swine-fever, is hereby declared to be free from swine-fever, and that Area shall, as from the commencement of this Order, cease to be an Area infected with swine-fever.

2. This Order shall take effect from and immediately after the tenth day of May, one thousand eight hundred and ninety.

(PLEURO-PNEUMONIA.)

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The Area described in the Schedule to this Order is hereby declared to be an Area infected with pleuro-pneumonia.

An Area round Parsonage Farm, West Thurrock, in the county of Essex, in the occupation of Mr. William Ellis, comprising the whole space commencing at a point on the north boundary of the river Thames at Brook's Wharf and running in a northerly direction along the road leading
