or by such other name and style as may appear to the bishop of the diocese to be more expedient.

when built and consecrated shall be vested in and shall be exercised by the Dean and Chapter of the Cathedral Church of Saint Paul and their successors, unless an endowment for such new church be provided from some sources which may, in the opinion of the Bishop of London, and of the said Dean and Chapter of the Cathedral Church of Saint Paul, make some other arrangement with respect to its patronage desirable and expedient.

"4. That such new church, when built and consecrated, may become the church of a separate ecclesiastical district to be formed hereafter under the provisions of the New Parishes Acts, or under the provisions of the Church Building Acts or

under some or one of such Acts.

"Provided always that this scheme shall not take effect until the consents and approval which by the said seventeenth section of the said Act of the twenty-third and twenty-fourth years of Your Majesty, chapter one hundred and forty-two, are made requisite to the sale or letting or appropriation under the powers conferred by that Act of the site of any church and to the mode of dealing with such site, shall be obtained to the said church of Saint Mary Magdalen, Old Fish-street, and of the site thereof together with any ground annexed thereto and necessary for the use or enjoyment thereof, and to the mode of dealing with such site which is hereby proposed.

"And provided also, that nothing herein contained shall prevent us, the said Ecclesiastical Commissioners for England from recommending and proposing any other matter or thing as to the measures aforesaid, or any of them, in accordance with the provisions of the said Act of the twenty-third and twenty-fourth years of Your Majesty, chapter one hundred and forty-two, or of any

other Act of Parliament."

And whereas the said scheme has been laid before both Houses of Parliament for the space of two calendar months.

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act of the twenty-third and twenty-fourth years of Her Majesty, chapter one hundred and forty-two, and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the seventh and eighth years of Her Majesty chapter ninety-four of the Act of the thirteenth and fourteenth years of Her Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Her Majesty chapter ninety-four duly prepared and laid before Her Majesty in Council a scheme or representation bearing date the first day of May, in the year

one thousand eight hundred and ninety, in the

words following, that is to say:—

"We the Ecclesiastical Commissioners for England acting under the provisions of the Act of the seventh and eighth years of Your Majesty, chapter ninety-four, of the Act of the thirteenth and fourteenth years of Your Majesty, chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Your Majesty chapter ninety-four have prepared and now humbly lay before Your Majesty in Council the following Scheme or Representation for altering the boundaries of the new parish of Saint Nathaniel, Windsor, West Derby in the county of Lancaster and in the dicesse of Liverpool.

"Whereas by the authority of an Order of Your Majesty in Council bearing date the twenty-eighth day of July, in the year one thousand eight hundred and seventy-one and published in the London Gazette upon the first day of August following a part of the particular district of Saint Clement Toxteth Park in the said county of Lancaster and at that time in the diocese of Chester was assigned as a district chapelry to the consecrated church of Saint Nathaniel situate at Windsor within the limits of such particular district and the same district chapelry was called 'The District Chapelry of Saint Nathaniel, Windsor, West Derby.'

"And whereas the said district chapelry of Saint Nathaniel, Windsor, West Derby has under the provisions of the Act of the nineteenth and twentieth years of Your Majesty chapter one hundred and four become a new parish of the character contemplated by that Act and by the Act of the sixth and seventh years of Your Majesty chapter thirty-seven and by the abovementioned Act of the thirty-second and thirty-

third years of Your Majesty chapter ninety-four.

"And whereas it has been represented and it appears to us to be expedient that the boundaries of the said new parish of Saint Nathaniel, Windsor, West Derby should be altered in the

manner hereinaster mentioned.

"Now therefore with the consent of the Right Reverend John Charles Bishop of the said diocese of Liverpool (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said new parish of Saint Nathaniel, Windsor, West Derby shall be altered so that all that portion of the new parish of Saint Catherine, Edge Hill in the said county and in the diocese of Liverpool aforesaid which is described in the First Schedule hereunder written and is delineated and set forth upon the map or plan hereunto appended and is thereon coloured green shall be dissevered from such new parish and shall be annexed to and shall in future form part of the said new parish of Saint Nathaniel Windsor, West Derby; and that in like manner all that portion of the parish of West Derby (being a part of the conventional district of Saint Mary Edge Hill) in the last-mentioned county and diocese which is described in the Second Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto appended and is thereon coloured yellow shall be annexed to and shall in future form part of the said new parish of Saint Nathaniel, Windsor, West Derby and that in like manner all that portion of the
