Gentlemen who propose to present others must send in writing the name of such Gentlemen to the Lord Chamberlain's Office, not later than two days previous to the Levee, in order that the Lord Chamberlain may submit the names to Her Majesty, when, if they are approved, Presentation Cards will be forwarded. Forms for the purpose can be obtained at the Lord Chamberlain's Office.

Gentlemen who wish to be presented officially should communicate with the heads of their Department, who will provide them with the necessary cards and instructions.

And whereas, on such representation and consideration, it appears to me that it would be for the convenience and advantage of the public that the said Fair should be abolished:

Now, therefore, I, as the Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1871," do hereby order that the Fair which has been annually held at Aspenden, in the county of Hertford, shall be abolished as from the date of this Order.

GENERAL ORDER of the Local Government Board: Altering General Consolidated Order: Allowance of Tobacco and Shuff to certain Paupers in the Workhouse:—

Stockport Union.

To the Guardians of the Poor of the Stockport Union, in the County Borough of Stockport and the Counties of Chester and Lancaster;—And to all others whom it may concern.

And to all others whom it may concern.

WHEREAS by a General Order dated the
24th day of July, 1847, addressed to the
Guardians of the Poor of the said Stockport
Union (among others), the Poor Law Commissioners made certain Rules and Regulations with
regard to the Government of the Workhouse or
Workhouses of the said Union;

And whereas it is expedient that further provision should be made as hereinafter mentioned:—

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order that, from and after the date hereof, the following regulations shall be in force in the said Stockport Union, namely,—

Union, namely,—
ARTICLE I.—Tobacco or Snuff may be allowed to such of the inmates of any Workhouse of the Union who are not able-bodied, or are employed upon work of a specially disagreeable character, as the Guardians may consider should be supplied with the same, the quantity to be allowed in each case, or in any class of cases, to be such as the Guardians may by resolution prescribe.

Guardians may by resolution prescribe.

ARTICLE II.—So much of Article 121 of the said General Order as provides that no pauper shall smoke in any room in the Workhouse without the special direction of the Medical Officer shall be rescinded, so far as regards the said Union; but the Guardians may from time to time, by resolution, determine in what rooms and at what times smoking shall be allowed, and no pauper shall smoke in the Workhouse in any other room or at any other time than is so allowed.

(PORT OF ABERDEEN—APPROVAL OF LANDING-PLACE FOR FOREIGN ANIMALS.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do hereby approve of the following part of the Port of Aberdeen as a landing-place for foreign animals not subject to slaughter or quarantine:

All that space in the parish of Saint Nicholas, in the burgh of Aberdeen, situate at Pocra Jetty on the north side of the tidal harbour of Aberdeen. and including the whole of the said jetty, and comprehended within the following boundaries namely,—commencing at a point on the rondway of Pocra Quay thirty-six feet north-east of the extreme west end of Pocra Quay wall, thence in a south-easterly direction for a distance of ten feet or thereabouts and bounded by a wooden fence, thence in a south-westerly direction for a distance of one hundred and fourteen feet or thereabouts and bounded by a wooden fence, thence in a southwesterly direction for a distance of thirty-four feet or thereabouts and bounded by a wooden fence, thence in a north-westerly direction for a distance of one hundred and sixty-five feet or thereabouts along the edge of the wharf of the said jetty, thence in a north-easterly direction for a distance of one hundred and seventy-two feet or thereabouts and bounded partly by a wooden fence and partly by the external wall of a cattle-shed, thence in a northeasterly direction for a distance of one hundred and five feet or thereabouts and bounded partly by a wooden fence and partly by the external walls of the slaughter-house and fodder-shed, thence in a south-easterly direction proceeding in a curved line for a distance of forty-one feet or thereabouts and bounded by the external walls of the foddershed, thence in a southerly direction proceeding in a curved line for a distance of one hundred and twenty feet or thereabouts and bounded by a wooden fence and four gates to the point on the roadway of Pocra Quay before mentioned, all which space is coloured pink on the plan of the said landing-place deposited for the purposes of

this Order at the office of the Board of Agriculture, a copy of which is deposited at the office of the ... Town Clerk of the burgh of Aberdeen.
