THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1886, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as

1. The following Area declared by Order of the Board to be an Area infected with pleuropneumonia (namely),—the county of Cumberland and the boroughs of Carlisle and Workington,—is, except such portion thereof as is included in the Area described in Article 2 of this Order, hereby declared to be free from pleuro-pneumonia, and the Area above described, except as aforesaid, shall, as from the commencement of this Order, cease to be an Area infected with pleuropneumonia.
