The following Area (namely),—comprising the county of Cumberland except the Leath Ward, the petty sessional division of Longtown, and the parish of Millom in the Bootle petty sessional division, and also comprising the boroughs of Carlisle and Workington,—shall continue to be and is hereby declared to be an Area infected with pleuro-pneumonia.

3. This Order shall take effect from and immediately after the ninth day of July, one thousand eight hundred and ninety.

FRANCE—NORTH COAST.

Dyck Light-vessel—Re-exhibition of Permanent Light, and Discontinuance of Provisional Lights.

WITH reference to Notice to Mariners, No. 278 of 1890, that in the course of the month of June, 1890, the permanent light would be re-exhibited from Dyck Light-vessel, and the provisional lights discontinued:—

The French Government has given further notice, that on 12th June, 1890, the permanent light was re-exhibited.

Dyck Permanent Light is a flashing white light, with flashes every twenty seconds, preceded and followed by eclipses, and elevated 39 feet above the sea.

The light-vessel carries a frame ball, 6½ feet in diameter and painted red, at the masthead.

Approximate position, lat. 51° 3' 10" N., long. 2° 7' 55" E.

ENGLAND—EAST COAST.—RIVER THAMES ENTRANCE.

Girdler Old Beacon Disappeared, and not to be Restored.

THE Trinity House, London, has given notice, dated 13th June, 1890, the old beacon on the South Spit of Girdler Sand, River Thames Entrance, has disappeared, and that it is not intended to restore it.
