## FOR REGISTRATION AS TEMPORARY BOY MESSENGER.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction, consisting of a piece or parcel of land, comprising one thousand nine hundred and sixteen square yards or thereabouts, which has been permanently secured to the vicarage of Saint Leonard, Bootle, in the county of Lancaster, and in the diocese of Liverpool, do hereby in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said vicarage of Saint Leonard, Bootle, to meet such benefaction, one capital sum of one thousand pounds sterling, to be applicable towards defraying the cost of providing a parsonage or house of residence for the said vicarage, according to plans and a specification approved or to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands, at interest after the rate of two pounds and ten shillings per centum per annum, and such interest to be paid to the Incumbent for the time being of the said vicarage of Saint Leonard, Bootle.
