THE following Statute, made by the Governing Body of Trinity College, Oxford, on the fifteenth day of July, one thousand eight hundred and ninety, and sealed on the twenty-fifth July, one thousand eight hundred and ninety, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions contained in the Universities of Oxford and Cambridge Act, 1877 :-

AT a meeting of the Governing Body of Trinity College, Oxford, specially called for the purpose, with notice of the business to be transacted thereat, held on Tuesday, July fifteenth, one thousand eight hundred and ninety, it was resolved by a majority of two-thirds of those present and voting, to make the following alteration in the College Statutes:-

In Statute II clause 21a of the Statute approved by Her Majesty in Council of thirteenth May one thousand eight hundred and eighty-seven to omit the words "but the payment of any such stipend shall be conditional on the attendance of the Fellow at the stated meetings of the College, if not prevented by reasonable cause."
