THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a Despatch, dated August 11, from Her Majesty's Representative at Stockholm, reporting that a notification of the Swedish Board of Health declares the ports within the Province of Hedjaz, in Arabia, and those within the Spanish Provinces of Castille, Valencia, and Andalusia to be infected with cholera. The notification also declares infected the ports of the Red Sea, Beyrouth, and Damascus in Syria, the ports of the British East Indies, Chalon in Cochin China, Tonkin, the Philippine Islands, China and Japan, Vladivostok in Siberia, Chile, and Salta in the Argentine Republic. Kanso is the quarantine harbour for ships infected with cholera.

Vessels with pilgrims from the East, or having had cases of cholera on board, shall not be permitted to enter this harbour.
