South Wales Audit District.

Colwyn and Painscastle Highway Districts.

To Edward Jones, District Auditor ;—

To the Highway Board for each of the Highway Districts of Colwyn and Painscastle ;—

And to all others whom it may concern.

WHEREAS by Section 4 of "The District Auditors Act, 1879," it is enacted that the Local Government Board may from time to time assign to District Auditors their Duties, and the Districts in which such Auditors respectively are to act, and may from time to time change wholly or in part such Duties or Districts ;

And whereas by an Order dated the 9th day of October, 1879, We, the Local Government Board, certified the appointment of the said Edward Jones as a District Auditor, and ordered and prescribed that the District in which he should act as Auditor, and which was thereby assigned to him, should, until We should otherwise prescribe, comprise the area for the time being included in the several Unions named in the Schedule to that Order, and that such District should be termed "The South Wales Audit District" :

And whereas by Article 2 of the said Order We ordered and prescribed that it should be the duty of the said District Auditor to audit the Accounts of the Authorities specified or referred to in paragraphs (1), (2), and (3) of that Article, and the Accounts of such of the other Authorities whose Accounts were or might be by law subject to be so audited, and whose Districts or the areas of whose jurisdiction were for the time being partly situated within the said Audit District, as We might, by Order under Seal thereafter prescribe ;

And whereas by an Order dated the 26th day of January, 1880, We directed that it should be the duty of the said Edward Jones to audit the Accounts of the School Board named in such Order ;

And whereas the Highway Board for each of the said Highway Districts of Colwyn and Painscastle is an Authority whose Accounts are subject to be audited by a District Auditor, and each of such Highway Districts is partly situated within the said Audit District :

Now therefore, in pursuance of the powers given to Us by the Statutes in that behalf, We hereby Order and Prescribe that it shall, until We otherwise prescribe, be the duty of the said Edward Jones to audit the Accounts of each of the said Highway Boards and of their Officers, in conformity with the provisions contained in Article 3 of the first above-cited Order ; and that for the purpose of such Audit the District of each of the said Highway Boards shall be deemed to be within the said South Wales Audit District.

To the Highway Board for each of the Highway Districts of Radnor and Vaynor ;—

And to all others whom it may concern.

WHEREAS by Section 4 of "The District Auditors Act, 1879," it is enacted that the Local Government Board may from time to time assign to District Auditors their Duties, and the Districts in which such Auditors respectively are to act, and may from time to time change wholly or in part such Duties or Districts ;

And whereas by an Order dated the 22nd day of January, 1890, We, the Local Government Board, certified the appointment of the said George Henry Brett as a District Auditor, and assigned to him certain duties and the District in which he should act as Auditor for the performance of the said duties, and directed that such District should be termed "The Herefordshire and Monmouthshire Audit District" ;

And whereas the Highway Board for each of the said Highway Districts of Radnor and Vaynor is an Authority whose Accounts are subject to be audited by a District Auditor, and each of such Highway Districts is partly situated within one or more of the Unions named in the said Schedule to the above-cited Order.

(PLEURO-PNEUMONIA.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Place (namely),—the four marshes known as the Clergymen and Widows' Marshes on the north-east corner of the Potter-Heigham Marshes, in the parish of Potter-Heigham, in the county of Norfolk, in the occupation of Thomas Slipper, Esquire,—which was declared by Order of the Board dated the twenty-second day of July, one thousand eight hundred and ninety, to be a Place infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Place shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the sixth day of September, one thousand eight hundred and ninety.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, and with reference especially to Article 96 of The Animals Order of 1886, do hereby license the Local Authority for the county of Stafford, to dig up or cause to be dug up, within fourteen days after the date of this Licence, the carcasses of two pigs belonging to Sarah Higgs which recently died and were buried in her garden, at Penn; subject to the following conditions:—

1. When dug up the Local Authority shall forthwith cause the carcasses to be examined with a view to ascertain whether the animals were affected with contagious or infectious disease, and the Local Authority shall then cause the carcasses to be re-buried as soon as possible, and shall cause them to be covered with a sufficient quantity of quick lime or

other disinfectant, and with not less than six feet of earth.

2. The expenses of and incidental to the digging up, examination, and re-burial of the carcasses shall be defrayed by the Local Authority.

3. This Licence is revocable by the Board of Agriculture.

*Unsuccessful Search for certain Dangerous Sunken Wrecks.*

WITH reference to Notice to Mariners, No. 254 of 1890, and previous Notices, on the dangerous sunken wrecks of the "Gaw Quan Sia" and "Leerdam," in the North Sea; the following particulars of recent unsuccessful searches for these wrecks are now promulgated for the information of Mariners:—

H.M.S. "Grappler," from 2nd to 5th May, 1890, unsuccessfully searched for the wrecks in the area included between lats.  $51^{\circ} 57'$  N. and  $52^{\circ} 2'$  N., longs.  $2^{\circ} 56'$  E. and  $3^{\circ} 11'$  E.

H.M. surveying-vessel "Triton" proceeded on 22nd May, 1890, to the reported position of buoys (lat.  $52^{\circ} 7'$  N., long.  $3^{\circ} 7'$  E.), placed by H.M. coastguard vessel "Rose," near a sunken wreck on which several trawlers had lost their nets. The buoys had broken adrift before the "Triton" reached the spot; and two days, with fine weather, were then spent by her in an unsuccessful search for the wrecks in the area included between lats.  $52^{\circ} 0'$  N. and  $52^{\circ} 12\frac{1}{2}'$  N., longs.  $2^{\circ} 58'$  E. and  $3^{\circ} 21'$  E. The Ramsgate fishermen stated that the wreck buoyed by the "Rose," was in all probability that of an iron barque which foundered there at the end of 1888, and not either the "Gaw Quan Sia" or the "Leerdam."

Between 14th June and 24th July, 1890, search was made for the wrecks by sweeping and cruising about in the undermentioned localities, by H.M. tug "Carron" and the salvage cutter



"Enigma," but no indications of the wrecks were found. The area examined by these vessels was included between lats.  $51^{\circ} 52\frac{1}{2}'$  N. and  $52^{\circ} 11'$  N., longs.  $2^{\circ} 56'$  E., and  $3^{\circ} 8'$  E., in lines running N.E. by N. and S.W. by S., but the weather was generally unfavourable. Several Ramsgate trawlers were boarded during this search, and reported that they had recently lost their trawls on the masts of the wrecks, but could give no information as to their position, nor as to whether their masts were standing upright; the fishermen stated that a strong ripple was to be seen over the wrecks in very calm weather. Trawling is now carried on further to the eastward for the purpose of avoiding the wrecks.

CAUTION.—As these wrecks lie, whatever their precise positions, in the track of vessels passing through the North Sea between the Strait of Dover and the north, and in other directions, the greatest care is necessary to avoid passing near the positions given.
