PRISON ACT, 1884.

47 and 48 Vic., cap. 51, sect. 2.

IN pursuance of the power conferred on me by the Prison Act, 1884, I hereby declare that the buildings heretofore used as the Prison for Convicts at Wormwood Scrubs, in the county of London, shall be a Prison under the Prison Act, 1865, and the Prison Act, 1877, and shall be under the jurisdiction of the Prison Commissioners, and shall be a Prison for the county of London, and also for the counties of Middlesex, Surrey, Kent, Essex, Hertford, and Buckingham.

(PLEURO-PNEUMONIA.)

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Place (namely),—in the parish of Wimbledon, in the county of Surrey, comprised within the following boundary, that is to say, starting from Christ Church and following Copse Hill, including the road, to Kingston-road, but not including that road, thence by the footpath at the bottom of Wimbledon Wood and by Mr. Clifford's private-road to the Rounds Wimbledon Common, but not including that road, and thence north-westerly by the side of the Common to Christ Church aforesaid,—which was declared by Order of the Board dated the twenty-fifth day of September, one thousand eight hundred and ninety, to be a Place infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Place shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after this ninth day of October, one thousand eight hundred and ninety.
