To the Guardians of the Poor of the Saint Saviour's Union, in the County of London;—

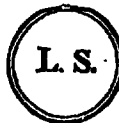
And to all others whom it may concern.

WHEREAS by a General Order dated the Twenty-second day of July, One thousand eight hundred and eighty-nine, We, the Local Government Board, prescribed certain Regulations prohibiting the admission into Metropolitan District Schools, except under certain conditions, of children suffering from any affection of the scalp, or of the skin, or of the eyes;—

Now therefore, in pursuance of the powers given to Us in that behalf, We do hereby Order that the provisions of the above-cited Order shall not be deemed to apply so as to prevent the admission forthwith into the Central London District School at Hanwell of the undermentioned children who are now inmates of the Separate Infirmary at East Dulwich, or of the Workhouse at Newington, belonging to the Guardians of the

Poor of the Saint Saviour's Union, namely:—
