THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a Despatch, dated October 31, from Her Majesty's Representative at Tunis, reporting that the postal service with Tripoli may now be resumed, and that the quarantine on arrivals from Vilayet will be raised, with the following limitations:—"Arrivals will be subjected to a sanitary visit at the first port at which they touch in Tunis. The landing of susceptible luggage is forbidden. Passengers will not be allowed to land unless they produce a certificate countersigned by the French Consul, certifying that they and their baggage have been disinfected. Pilgrim ships which have touched at Tripoli will continue to be subjected to a quarantine of eight days."
