

along the middle of the last-named street for a distance of seven and a half chains or thereabouts to the boundary at the junction of the said last-named street with Leeming-street which boundary divides the said parish of Saint Peter Bradford from the new parish of Christ Church Bradford aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Ripon.

**W**HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, and of the Act of the seventeenth and eighteenth years of Her Majesty, chapter eighty-four, duly prepared and laid before Her Majesty in Council a scheme bearing date the eleventh day of December, in the year one thousand eight hundred and ninety, in the words following, that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the third and fourth years of Your Majesty, chapter one hundred and thirteen, and of the Act of the seventeenth and eighteenth years of Your Majesty, chapter eighty-four, have prepared and now humbly lay before Your Majesty in Council the following scheme for apportioning the income of the benefice and united rectory of All Hallows Lombard-street with Saint Benet Gracechurch Saint Leonard Eastcheap and Saint Dionis Backchurch, in the city of London, and in the diocese of London, between that benefice and the benefice (being a rectory) of Saint George the Martyr with Saint Mary Magdalene, Canterbury, in the county of Kent and in the diocese of Canterbury.

"Whereas the Dean and Chapter of the Metropolitan Church of Christ at Canterbury are the patrons of both the aforesaid benefices and have requested us to recommend to Your Majesty in Council the apportionment hereinafter recommended and proposed.

"And whereas under the provisions of an Order of Your Majesty in Council dated the twenty-third day of October in the year one thousand eight hundred and seventy-six, and published in the London Gazette on the twenty-seventh day of the same month, the endowments or some portion thereof of the benefice and united rectory of All Hallows Lombard-street with Saint Benet Gracechurch Saint Leonard Eastcheap and Saint Dionis Backchurch, are subject to the payment now or in futuro of certain annual rent-charges in favour of certain benefices or cures specified in the same Order of Your Majesty in Council.

"And whereas it has been made to appear to us that the said benefice of Saint George the Martyr with Saint Mary Magdalene Canterbury is at present insufficiently endowed and that the

said benefice and united rectory of All Hallows Lombard-street with Saint Benet Gracechurch Saint Leonard Eastcheap and Saint Dionis Backchurch has endowments of such an amount as that after allowing for the several charges specified in the said Order of Your Majesty in Council dated the twenty-third day of October in the year one thousand eight hundred and seventy-six, and for the other charge hereinafter recommended and proposed to be made upon the same endowments, the lastly-mentioned benefice will still be sufficiently endowed.

"And whereas the Right Honourable and Most Reverend Edward White, Archbishop of Canterbury, and the Right Honourable and Right Reverend Frederick, Bishop of the said diocese of London, and we, the said Ecclesiastical Commissioners for England, are of opinion that it is desirable that additional provision should be made for the cure of souls within the parish of Saint George the Martyr with Saint Mary Magdalene Canterbury by means of that apportionment of the income of the said benefice and United Rectory of All Hallows Lombard-street, with Saint Benet Gracechurch Saint Leonard Eastcheap and Saint Dionis Backchurch which is hereinafter recommended and proposed.

"And whereas the said benefice and united rectory of All Hallows Lombard-street with Saint Benet Gracechurch, Saint Leonard Eastcheap and Saint Dionis Backchurch is now full of a clerk.

"Now therefore with the consent of the said Edward White, Archbishop of Canterbury (in testimony whereof he hath to this scheme set his hand and affixed his archiepiscopal Seal) and with the consent of the said Frederick, Bishop of the said diocese of London, acting as such Bishop (in testimony whereof he hath to this scheme set his hand and affixed his episcopal seal) and with the consent of the said Dean and Chapter of the Metropolitan Church of Christ at Canterbury as the patrons of each of the said two benefices as aforesaid (in testimony whereof they have to this scheme affixed their common or corporate seal) we the said Ecclesiastical Commissioners for England, humbly recommend and propose that without any conveyance or assurance in the law other than this scheme and any duly gazetted Order of Your Majesty in Council ratifying the same, and as from the day of the date at which the said benefice and united rectory of All Hallows Lombard-street with Saint Benet Gracechurch Saint Leonard Eastcheap and Saint Dionis Backchurch shall from whatever cause be next voided all the tithes or annual sums in lieu of tithes glebe lands and all (if any) other the endowments which shall at the date of the next avoidance of the said benefice and united rectory of All Hallows Lombard-street, with Saint Benet Gracechurch, Saint Leonard Eastcheap and Saint Dionis Backchurch or which may thereafter belong to the same benefice and united rectory shall be charged and for ever thereafter be chargeable in favour of the incumbent for the time being of the said benefice of Saint George the Martyr with Saint Mary Magdalene Canterbury with the further annual sum or yearly charge hereinafter mentioned that is to say a clear annual sum or yearly charge of one hundred pounds to be as from the day last aforesaid due and payable to the incumbent of the said benefice of Saint George the Martyr with Saint Mary Magdalene Canterbury and to be apportionable between any outgoing incumbent of the said benefice of Saint George the Martyr with Saint Mary Magdalene Canterbury or his representatives on the one hand and his successor in the
