THE Board of Trade have received, through the Secretary of State for Foreign Affairs, from Her Majesty's Representative at Madrid, a Translation of a Notice, issued on the 7th instant by the Spanish Ministry of the Interior, intimating that the precautions which have been adopted against the free traffic in, or transit and circulation of, fruit, linen, skins, feathers, furs, wool, cotton, flax, hemp, paper, hides, and every kind of infectious merchandise, even though proceeding from places visited during the last year by cholera, will be abolished.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a Despatch, dated January 9, from Her Majesty's Representative at Buda-Pesth, transmitting a translation of a Circular which was issued, on the 24th December, 1890, by the Hungarian Maritime Government, by which the quarantine measures against arrivals from Spain were revoked, and it was decreed that arrivals from Spanish Mediterranean ports, ports to the west of Gibraltar as far as the frontier of Portugal, and ports of the Balearic Islands should, after a rigorous medical inspection, be admitted to free pratique if found to be in a perfectly normal condition.
