THE FAIRS ACT, 1871. ROYDON FAIR.

IN pursuance of the above-mentioned Act, J, the Right Honourable Henry Matthews, one of Her Majesty's Principal Secretaries of State, hereby notify as follows:-

1. By Memorial, dated the 23rd day of January, 1891, a representation has been duly made to me by Her Majesty's Justices of the Peace acting in and for the Petty Sessional Division of Harlow, in the county of Essex, that a Fair has been annually held at Roydon, within the said Petty Sessional Division, and that it would be for the convenience and advantage of the public that such Fair should be abolished:

2. On the 2nd day of March, 1891, I shall take the aforesaid representation into consideration, and all persons are to intimate, before that day, any objection they may desire to offer to the abolition of the said Fair.
