Sunken Rock South-west of South Extreme of
Rutland Island.

THE following information has been received from Commander R. F. Hoskyn, R.N., in charge of Marine Survey of India, concerning an examination, made on 10th and 11th December, 1890, in the Indian Marine ship "Investigator," of the locality lying in a S.S.W. direction from the south extreme of Rutland Island, in search of a sunken rock, with 3 fathoms water on it, reported by the master of the steam ship "Kohinur," as being situated with the south extreme of Rutland Island bearing N. by E., distant 2 miles:—

An area about 2 miles in width (east and west), and extending about $4\frac{1}{2}$ miles in a S. by W. direction from the south extreme of Rutland Island, was closely sounded, the depths found being in general agreement with those shown on the Admiralty Charts. The "Investigator" remained at anchor for 21 hours of daylight in the reported position of the rock above given, and although the tide ran about $1\frac{1}{4}$ knots an hour for the greater part of the time, no indications of shoal water were seen, and Commander Hoskyn was satisfied that no shoal ground exists in the immediate locality.

A rock (Kohinur Rock) was however found, with a depth of 3 fathoms on it, and nearly always marked by a tide rip, lying with the south extreme of Rutland Island bearing N.N.E. \(\frac{3}{4}\) E., distant 9 cables, and the south-west extreme of Rutland Island N.N.W. \(\frac{3}{4}\) W.; depths of under 10 fathoms extend about 3 cables north and south of Kohinur Rock, and about 2 cables east and west of it; and a patch of \(4\frac{1}{2}\) fathoms lies on the north-east edge of this shoal ground.
