never before been buried in and which when opened are free from water) burials may be allowed, at their decease respectively, of General Pearson and Mr. Francis Pym, and of so many members of their families as can be buried at or below the depth of five feet.

(a.) In such partly-walled graves existing on the thirty-first of March, one thousand eight hundred and ninety-one, provided that the earth above them can be opened to the depth of five feet without exposing coffins or disturbing human remains, burials may be allowed of so many of the relations of those interred therein on the thirty-first of March, one thousand eight hundred and ninety-one, as can be buried at or below that depth.

(b.) In such earthen graves existing on the thirty-first of March, one thousand eight hundred and ninety-one, as can be opened to the depth of five feet without exposing coffins or disturbing human remains burials may be allowed of so many of the relations of those interred therein on the thirty-first of March, one thousand eight hundred and ninety-one, as can be buried at or below that depth.

W HEREAS Robert Woodfall, Esquire, Barrister-at-Law, duly appointed in pursuance of the Municipal Corporations Act, 1882, as Commissioner for determining the boundaries of the Wards of the borough of Welshpool and for apportioning the Councillors thereto, has transmitted to one of Her Majesty's Principal Secretaries of State his scheme in the following terms :--

" MUNICIPAL CORPORATIONS ACT, 1882.

" 45 and 46 Victoria, c. 50.

"Borough of Welshpool

"WHEREAS Her Majesty has been pleased by and with the advice of Her Privy Council and in pursuance and exercise of the power vested in Her Majesty by the Municipal Corporations Act 1882 to fix the number of Wards into which the borough of Welshpool shall be divided, and to order and direct that the said borough shall be divided into four Wards, which Order was made on the twenty-first day of October one thousand eight hundred and ninety.

"And whereas on the fourth day of November one thousand eight hundred and ninety the Right Honourable Henry Matthews, one of Her Majesty's Principal Secretaries of State, in pursuance of the thirtieth section of the said Act did duly warrant and appoint Robert Woodfall Esquire, Barristerat-Law, to be a Commissioner to prepare a scheme for determining the boundaries of such Wards and for apportioning the Councillors of the said borough among such Wards as in the said Act directed.

"Now I the said Robert Woodfall do hereby in pursuance of the said Warrant and Appointment determine as hereinafter mentioned the boundaries of the four Wards into which the said borough is to be divided which Wards are hereinafter numbered and named as follows that is to say :--

- "Ward No. 1 otherwise Buttington Ward.
- "Ward No. 2 otherwise Castle Ward.
- " Ward No. 3 otherwise Llanerchydol Ward.
- " Ward No. 4 otherwise Guilsfield Ward.

"And I do hereby determine that the said Ward No. 1 otherwise Buttington Ward shall comprise so much of the said borough of Welshpool as is contained within a line commencing at Kilkewydd Bridge and drawn thence in a westerly and north-westerly direction along the centre of Berriew-road and Berriew-street, thence along the centre of Church-street and Salop-road to and as far as a point in the centre of Buttington Bridge over the River Severn to and as far as the northern boundary of the borough at Pool Quay, thence in a north-easterly and southerly direction along and following the borough boundary to and as far as the point of commencement aforesaid.

" And I do hereby determine that Ward No. 2 otherwise Castle Ward shall comprise so much of the said borough of Welshpool as is contained within a line commencing at the said Kilkewydd Bridge and drawn thence in a north-westerly and northerly direction along the centre of the said Berriew-road and Berriew-street to and as far as the Cross, thence in a westerly direction along the centre of Broad-street, High-street, Mount-street and Raven-street to and as far as the junction of the Guilsfield-road with the Llanfair-road, thence in a westerly direction along the centre of the said Llanfair-road to and as far as the western boundary of the borough, thence in a southwesterly and south-easterly direction along and following the borough boundary to and as far as the point of commencement aforesaid.

"And I do hereby determine that the said Ward No. 3 otherwise Llanerchydol Ward shall comprise so much of the said borough of Welshpool as is contained within a line commencing at a point in the centre of Broad-street opposite the southern end of Hall-street and drawn thence in a westerly direction along the centre of Highstreet, Mount-street and Raven-street all aforesaid, to and as far as the said junction of the Guilsfield-road with the Llanfair-road, thence along the centre of the said Llanfair-road to and as far as the western boundary of the borough thence northerly and easterly along and following the borough boundary to and as far as the Groes in the parish of Guilsfield at a point in the centre of the bridge over the brook crossing the Llanfyllin-road, thence in a southerly direction along the centre of the Llanfyllin-road, and the Guilsfield-road to and as far as the said junction of the said Guilsfield-road with the said Llanfair-road, thence in a north-easterly direction along the centre of the Back-road to and as far as a point in the northern end of Hall-street aforesaid, thence along the centre of the said Hall-street to and as far as the point of commencement aforesaid.

"And I do hereby determine that the stid Ward No. 4 otherwise the Guilsfield Ward shall comprise so much of the said borough of Welshpool as is contained within a line commencing at a point in the centre of Broad-street opposite the southern end of Hall-street, and drawn thence along the centre of Broad-street to and as far as the Cross, thence along the centre of Churchstreet and Salop-road aforesaid to and as far as the said Buttington Bridge, thence along the centre of the River Severn to and as far as the said northern boundary of the borough at Pool Quay aforesaid, thence in a westerly direction along the borough boundary and as far as the Groes afore-
