INFORMATION has been received that the Master of the British steam-vessel "Peterboro" reports having passed, at 1h. 30m. P.M., on 9th February, 1891, a sunken wreck, when about 32 miles E.S.E. from Outer Gabbard Lightvessel, or in approximately lat. 51° 56' N., long. 2° 56' E.

The lower mast of the wreck was showing about four feet above water, and the lower yard arm about 12 feet above water.

This wreck presents a danger to shipping.

And whereas the Right Reverend John Charles, Bishop of the said diocese of Liverpool, and the Reverend Percy Stewart, Rector of the parish of Saint Mary the Virgin, West Derby, in the said county of Lancaster, and in the said diocese of Liverpool, and as such Rector, Patron of the said new parish of Saint Ann, Stanley, and the Reverend Walter James Scarlin, the Incumbent of the same new parish, have, by an instrument under their hands, bearing date on or about the seventh day of October, in the year one thousand eight hundred and ninety, certified to us, the said Ecclesiastical Commissioners for England, that it would be for the convenience of the said new parish of Saint Ann, Stanley, that the said new church of Saint Anne, situate within such new parish, should be substituted for the old parish church (also dedicated to Saint Anne) of the same new parish.

Now, therefore, we, the said Ecclesiastical Commissioners for England, in exercise and execution of the power or authority in that behalf contained in the Act of the eighth and ninth years of Her present Majesty, chapter seventy, and in the Act of the nineteenth and twentieth years of Her said Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling us in the same behalf, do, by this instrument under our common scal, with the consent (testified as hereinafter mentioned) of the said John Charles, Bishop of the said diocese of Liverpool, and of the said Percy Stewart, and of the said Walter James Scarlin, hereby declare that the said new church of Saint Anne, situate within the said new parish of Stanley, Saint Ann, and duly consecrated as aforesaid, shall be, and the same is hereby, substituted for the said old parish church, dedicated to Saint Anne as aforesaid of the same new parish, and that such new church shall henceforth be the parish church of the said new parish of Stanley, Saint Ann, in lieu of the said old parish church of the same new parish, as fully in all respects as if the said new church of Saint Anne so hereby substituted, had been originally the parish church of the same new parish.
