CANADA AND THE UNITED KINGDOM.

TREASURY WARRANT.

WE, the Commissioners of Her Majesty's Treasury, in pursuance of the Acts relating to Her Majesty's Post Office, and in exercise of all powers enabling us in this behalf, do, by this Warrant, made on the representation of Her Majesty's Postmaster-General (testified by his signing the same), and under the hands of two of us, the said Commissioners, order, direct, and declare as follows :-

Repeal.

1. From and after the date when this Warrant comes into operation the Warrant of the Commissioners of Her Majesty's Treasury, dated the twenty-second day of August, one thousand eight hundred and eighty-nine, and relating to the transmission of Parcels by post between the United Kingdom and Canada shall be repealed, revoked, and annulled.

Definition.

- 2. In this Warrant :-(1.) The expression "Parcel" means a Postal Packet which is posted as a Parcel in accordance with the provisions of this Warrant, or any Warrant amending the same.
- (2.) The expression "United Kingdom" in-
