(Port of Grimsby—Definition of Foreign Animals Wharf.)

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under The Board of Agriculture Act, 1889, and The Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do hereby define the following part of the Port of Grimsby as a foreign animals wharf:

All that space at the Great Grimsby Royal Dock, in the borough of Grimsby, situate on the north-west side of the lock, known as the 70 feet lock, of the said Royal Dock, bounded by a line commencing at the water of the said lock at a point nineteen feet or thereabouts from the north corner of the said lock, thence running in a straight line in a north-westerly direction for one hundred and six feet or thereabouts along the northern side of certain cattle-pens, slaughter-house, and premises to the north-west corner thereof, thence running in a straight line in a south-westerly direction for two hundred and eighty-one feet or
