W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth, chapter seventy-seven, of the Act of the third and fourth years of Her Majesty chapter one hundred and thirteen, and of the Act of the thirty-seventh and thirty-eighth years of Her Majesty chapter sixty-three, duly prepared and laid before Her Majesty in Council a Scheme bearing date the sixteenth day of July, in the year one thousand eight hundred and ninety-one, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth, chapter seventy-seven, of the Act of the third and fourth years of Your Majesty, chapter one hundred and thirteen, and of the Act of the thirty-seventh and thirty-eighth years of Your Majesty, chapter sixty-three, have prepared and now humbly lay before Your Majesty in Council the following Scheme with respect to the rural deaneries or some or one of them which are within the Archdeaconry of Wrexham in the Diocese of Saint Asaph.

"Whereas by an Order of Your Majesty in Council bearing date the twenty-first day of March in the year one thousand eight hundred and ninety and published in the London Gazette, on the twenty-fifth day of the same month ratifying a Scheme prepared by us the said Ecclesiastical Commissioners for England, the said Archdeaconry of Wrexham was constituted, and in the Schedule to that Scheme annexed were set forth the names of the several rural deaneries within that archdeaconry.

"And whereas it has been represented to us by the Right Reverend Alfred George Bishop of the said diocese of Saint Asaph that the arrangements which are hereinafter recommended and proposed with respect to the said rural deaneries, or some or one of them, are desirable and should be carried into effect. And we are of opinion that the same may be properly carried into effect.
