John Southall Green in the county of Middlesex, | bridge or culvert which carries the main line of and in the diocese of London.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of the Holy Trinity Southall situate as aforesaid.

" Now therefore, with the consent of the Right Honourable and Right Reverend Frederick Bishop of the said diocese of London (testified by his having signed and sealed this representation), we, the said Ecclesiastical Commissioners humbly represent that it would in our opinion be expedient that all that part of the said new parish of Saint John Southall Green which is described in the schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a district chapelry to the said church of the Holy Trinity Southall situate as aforesaid, and that the same should be named 'The District Chapelry of the Holy Trinity Southall.

"And with the like consent of the said Frederick Bishop of the said diocese of London (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of the Holy Trinity Southall situate as aforesaid, and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being: Provided always that so long as the Reverend John Jackson Clerk in Holy Orders the present vicar or incumbent of the vicarage of the said new parish of Saint John Southall Green shall continue to be such vicar or incumbent all the fees which may be received in respect of such publication, solemnization, or performance at the said church of the Holy Trinity Southall situate as aforesaid shall be paid over by the minister thereof to the said John Jackson; and, Provided also that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the per-formance of the said office of baptism or for the registration thereof.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto, as to Your Majesty, in Your Royal wisdom, shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of the Holy Trinity, Southall, being :-

" All that part of the new parish (sometime particular district) of Saint John Southall Green, in the county of Middlesex, and in the diocese of London, which is bounded upon part of the south by the parish of Norwood, upon the east by the parish of Hanwell, upon the north-east partly by the parish of Greenford and partly by a certain small detached portion of the parish of Northolt, all which parishes are in the county and diocese aforesaid, upon the north by the said parish of Northolt, upon the north-west by the parish of Hayes, in the same county and diocese, and upon the remaining part of the south by an imaginary line commencing upon the boundary which divides the said parish of Hayes from the said new parish of Saint John Southall Green at the centre of the В

the Great Western Railway over the River Crane and extending thence north-eastward along the middle of the said main line of railway for a distance of one mile and twenty-seven chains or thereabouts to the boundary at the point where the old church path crosses the same main line of railway near to Southall Station and near to the junction of the said main line of railway with the Brentford branch of the same line of railway, which boundary divides the said new parish of Saint John Southall Green from the parish of Norwood aforesaid.

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts ; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Londor. WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the twenty-third and twenty-fourth years of Her Majesty, chapter one hundred and fortytwo, duly prepared and laid before Her Majesty in Council a Scheme bearing date the twentyeighth day of July, in the year one thousand eight hundred and ninety-one, in the words and figures following, that is to say :-

"We, the Ecclesiastical Commissioners for England acting in pursuance of the Act of the twenty-third and twenty-fourth years of Your Majesty, chapter one hundred and forty-two, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting an union of two contiguous benefices within the metropolis-namely the benefice (being a rectory) of Saint George in the East, situate in the county of Middlesex, and in the diocese of London, and the benefice (being a vicarage) of Saint Matthew, Pell-street, situate in the county and diocese aforesaid.

"Whereas the Right Honourable and Right Reverend Frederick, Bishop of the said diocese of London has caused proposals for a scheme for effecting an union of the said two benefices to be laid before us, which proposals are prepared under the seventh and eighth sections of the Act hereinbefore mentioned, and hereinafter referred to as the said Act, and are approved by the said Frederick, Bishop of the said diocese of London, as such Bishop, and also as the Patron, in right of his See, of the said rectory of Saint George in the East and of the said vicarage of Saint Matthew, Pell-street, and the same proposals are also assented to by the vestries of the two parishes concerned-that is to say, by the vestry of the parish of Saint George in the East, and by the vestry of the New Parish of Saint Matthew Pellstreet.

"And whereas it appears to us, the said Ecclesiastical Commissioners, to be expedient that the said proposed union of the said two benefices should be effected, and that such arrangements
