THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 18th October, 1891, from Her Majesty's Representative at Athens, reporting that the quarantine imposed on arrivals from the Syrian coast, between Tripoli and Sidon, is extended to the ports between Sidon and Jaffa (excluding the latter port). The quarantine is to be performed at Delos.
