OTICE is hereby given, that the Mayor and Commonalty and Citizens of the city of London (hereinafter called "the Corporation") intend to apply to Parliament in the ensuing session for leave to bring in a Bill and to pass an Act for all or some of the following purposes, or

some of them, namely :-

1. To provide that all bonds and other instruments which shall be issued under the provisions contained in the Acts hereinafter mentioned shall be stamped with such duty as may be specified in the Bill, or as may be agreed upon between the Corporation and the Commissioners of Inland Revenue, and to provide, if necessary, that any bonds or other instruments as aforesaid, which may have been already issued by the Corporation under the said Acts, or any of them, shall be deemed to have been duly and sufficiently stamped, and to declare, if necessary, that no duty shall be chargeable or payable on any transfers or assignments, whether made before or after the passing of the intended Act, of any such bonds as aforesaid.
