SWEDEN—WEST COAST.—SKAGERRAK—KOSTER ISLANDS.

*Discontinuance of Nord Koster Lights, and Exhibition of Fixed Lights on Ursholmar.*

WITH reference to Notice to Mariners, No. 203 of 1891:—

The Swedish Government has given further notice, that on 30th November, 1891, the two lights previously shown from Nord Koster, Koster Islands, would be discontinued.

Approximate position, lat. 58° 54' N., long. 11° 1' E.

Also, that on the same date, two lights would be exhibited on Ursholmar (Ursholmen), Koster Islands:—

Ursholmar Lights, visible in all directions, are fixed white lights, with the exception of an arc of flashing white light, shown from the southern lighthouse through an arc of 57°, or from the bearing of N. 52° E. to N. 5° W., over Persgrunden and Segelskären. The lights are elevated 108 feet above the sea, and should be seen in clear weather from a distance of 16 miles.

The illuminating apparatus is dioptric, or by lenses, of the third order.

The lighthouses, 44 feet high, circular in shape and gray in colour, are 44 yards apart in a N. 4° W. and S. 4° E. direction.

Approximate position, lat. 58° 50' 5" N., long. 10° 59' 45" E.
