

new parish of Pemberton aforesaid and extending thence south-eastward along the last-mentioned boundary for a distance of nineteen chains or thereabouts (thereby following the middle of the River Douglas aforesaid) to the point at the confluence of Barley Brook with the said river where the last-mentioned boundary meets the boundary which divides the said district chapelry of Saint Michael and All Angels Wigan from the parish of (All Saints) Wigan aforesaid and extending thence north-eastward along the last-mentioned boundary for a distance of seven chains or thereabouts (thereby following the middle of the said Barley Brook) to a point in the middle of the Leeds and Liverpool Canal aforesaid and extending thence first south-eastward, then southward, and then again south-eastward along the middle of the said canal for a distance of thirty-seven chains or thereabouts (thereby crossing the said Liverpool Bury and Manchester Line of the Lancashire and Yorkshire Railway aforesaid and also crossing at the same point the boundary which divides the said parish of (All Saints) Wigan from the new parish of Saint Thomas Wigan aforesaid) to the centre of Seven Stars Bridge which carries the hereinbefore-mentioned high road leading from Wigan to Warrington over the said canal and extending thence south-westward along the middle of the same high road for a distance of eight and a half chains or thereabouts to the first-described point at the centre of the viaduct which carries the last-mentioned line of railway over the same high road where the boundaries of the said new parish of Saint Thomas Wigan of the said parish of (All Saints) Wigan and of the new parish of Saint James Wigan all meet at which point the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Liverpool.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Representative at Athens, enclosing the following Quarantine Notice issued by the Greek Government, viz. :—

Royal Decree.

[In the Official Journal, dated 21 Nov. (Dec. 3), 1891.]

George I. King of the Hellenes.

HAVING taken into consideration paragraph 5 of Article 13 of the Sanitary Law, upon the proposal of our Minister of the Interior, we have resolved and do order :—

(a.) An observation of five days, to be performed at any port of the kingdom where there is a Health Office of the 1st Class, will henceforward be imposed upon vessels and steamers which have sailed on and after the 5 (17th) November, from ports situated between Mersina, exclusive, and Laodicea, inclusive. The above stated observation will be in lieu of the hitherto imposed eleven days' quarantine.

(b.) The eleven days' quarantine ordered by our decrees of the 2nd August and 3rd and 5th October last, will be only maintained with regard to arrivals from ports situated between Laodicea and Jaffa, these two cities not being included in this quarantine.

(c.) Vessels and steamers that may be under quarantine and which have arrived from ports situated between Mersina and Laodicea, inclusive, which may have left those ports on and after the 5th (17th) of November, will be admitted to pratique as soon as they have completed five days' observation.

The abovementioned Minister will publish and execute the present Royal Decree.
