

KENSINGTON ROAD, De Vere Gardens.	Twenty-seven Carriages. In Kensington Road: to commence thirty-seven yards East of a point opposite Victoria Road, and extend Eastwards along the North side of the road, close to the kerb as far as necessary for twenty-five Hackney Carriages; keeping clear of the crossing and gateway leading into Kensington Gardens; and again commencing twelve yards West of Victoria Road Gate, and extending Westward as far as necessary for two Carriages. Horses' heads to face Westward.
FULHAM ROAD, Walham Green, (Broadway).	Four Carriages. On East side of Fulham Road, Walham Green, at St. John's Schools, to commence eight yards North of the Cattle Drinking Trough, with horses' heads southwards.
SILVER STREET, Edmonton.	One Carriage. At Silver Street, Edmonton, on the West side of the Railway Station.
ST. MARK'S ROAD, St. Quintin Avenue.	Four Carriages. In the centre of the roadway at the junction of St. Mark's Road and St. Quintin Avenue; two carriages to stand on either side of the refuge with horses' heads facing East.

APPOINTMENT OF STANDINGS FOR HACKNEY CARRIAGES CANCELLED.

CANCELLATIONS.

HORNSEY ROAD, Seven Sisters Road.	Four Carriages. Commencing three feet from the crossing in the Seven Sisters Road, Holloway, and extending Northwards close to the kerb on the west side of Hornsey Road, horses' heads towards the Seven Sisters Road.
KINGSLEY ROAD, Hounslow.	Two Carriages. At the South-East corner of Kingsley Road, at its junction with London Road, Hounslow (outside the Old Hounslow Town Station, District Railway), the horses' heads facing Southwards as far as may be necessary for two hackney carriages to stand.
STATION ROAD, South Norwood.	Six Carriages. In centre of Station Road, High Street, South Norwood, commencing opposite the "Alliance" Public-House, extending towards Railway Station; horses' heads towards Selhurst Park
KENSINGTON ROAD, De Vere Gardens.	Twenty-five Carriages. At Kensington Road, De Vere Gardens, Kensington.
WALHAM GREEN, Fulham.	Four Carriages. At Walham Green, Fulham, in the centre of the roadway opposite the Swan Brewery, to the East of St. John's Schools. To commence eight yards from the Cattle Drinking Trough, with horses' heads Eastwards.
UPPER TULSE HILL, Lower Tulse Hill.	Three Carriages. By the dead wall (two yards from the crossing) on North side of Upper Tulse Hill, by Lower Tulse Hill.

THE RABIES (MUZZLING OF DOGS) ORDER OF 1889, AMENDMENT No. 10.

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Exemption from Muzzling of Dogs with Collars &c. in part of District.

1. From and after the commencement of this Order, the Rabies (Muzzling of Dogs) Order of 1889 shall in its application to the part of the District of the Local Authority mentioned in the Schedule to this Order be read and have effect as if the following paragraph were inserted at the end of Article 6 (*Muzzling of Dogs*) of the said Order of 1889, namely
