THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do direct and order, and it is hereby directed and ordered, as follows :

1. Notwithstanding anything in the Order of the Privy Council dated the sixteenth day of September, one thousand eight hundred and eighty-six, the provisions of Article 73 (Swine-Fever Infected Circle) of the Animals Order of 1886, as amended by Article 2 of the Animals (Amendment) Order of 1888, No. 2, shall, as from the commencement of this Order, no longer apply or extend to or be in force in the District of the county of Chester.

2. All Regulations made by the Local Authority of the county of Chester under the said Article 73 of the Animals Order of 1886, and in force at the commencement of this Order, are hereby revoked.

3. Nothing in this Order shall be deemed to invalidate or make unlawful anything done under the said Article 73 of the Animals Order of 1886, as amended by Article 2 of the Animals (Amendment) Order of 1888, No. 2, or under any Regulation made thereunder before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against or any penalty incurred thereunder before the commencement of this Order.

4. This Order shall commence and take effect from and immediately after the twenty-fifth day of January, one thousand eight hundred and ninety-two.
