THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

The Order of the Board dated the twenty-sixth day of October, one thousand eight hundred and ninety-one, prohibiting the sale or exposure for sale of any cattle, sheep, or swine in or at certain Market-places at Nailsworth and Stroud, and certain Sale-yards at Berkeley Road, Lydney, and Yate, in the county of Gloucester, shall be read and have effect as if the first day of April, one thousand eight hundred and ninety-two were substituted for the first day of February, one thousand eight hundred and ninety-two in Article 3 of that Order, as the date from and immediately after which that Order shall take effect.

**(PLEURO-PNEUMONIA.)**

By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The following Place (namely),—the cowsheds and stables of Elder Road Dairy in Elder-road, West Norwood, in the county of London, in the occupation of Mr. James Bacon,—which was declared by Order of the Board dated the twenty-eighth day of October, one thousand eight hundred and ninety-one, to be a Place infected with pleuro-pneumonia, is hereby declared to be free from pleuro-pneumonia, and that Place shall, as from the commencement of this Order, cease to be a Place infected with pleuro-pneumonia.

2. This Order shall take effect from and immediately after the twenty-sixth day of January, one thousand eight hundred and ninety-two.
