GENERAL ORDER of the Local Government Board: Altering General Consolidated Order: Allowance of Tobacco and Snuff to certain Paupers in the Workhouse:-

Dover Union.
To the Guardians of the Poor of the Dover Union, in the County of Kent ;-

And to all others whom it may concern.
WHEREAS by a General Order dated the 24th day of July, 1847, addressed to the Guardians of the Poor of the said Dover Union (amongst others), the Poor Law Commissioners made certain Rules and Regulations with regard to the government of the Workhouse of the said Union;

And whereas it is expedient that further provision should be made as hereinafter mentioned:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order that, from and after the date hereof, the following regulations shall be in force in the said Dover Union, namely,—
ARTICLE I.—Tobacco or snuff may be allowed

to such of the inmates of the Workhouse of the Union who are not able-bodied, or are employed upon work of a specially disagreeable character, as the Guardians may consider should be supplied with the same, the quantity to be allowed in each case, or in any class of cases, to be such as the

Guardians may by resolution prescribe.

ARTICLE II.—So much of Article 121 of the said General Order as provides that no pauper shall smoke in any room in the Workhouse without the special direction of the Medical Officer shall be rescinded, so far as regards the said Union; but the Guardians may from time to time, by resolution, determine in what rooms and at what times smoking shall be allowed, and no pauper shall smoke in the Workhouse in any other room or at any other time than is so allowed.

By the Board of Agriculture. THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as.

1. No cattle, sheep, goats, or swine shall be moved out of the district described in the Schedule to this Order: Provided that nothing inthis Order shall be deemed to apply to the movement of animals by railway through the said district from a place outside the said district to another place outside the said district without untrucking within the said district.

2. This Order shall commence and take effect from and immediately after this seventeenth day.
