1. From and after the commencement of this Order the Foot-and-Mouth Disease (Markets) Temporary Order of 1892 dated the eighth day of February, one thousand eight hundred and ninety-two, shall not apply to the Metropolitan Cattle Market at Islington in the county of London.

2. The Order of the Board of Agriculture dated the fourth day of February, one thousand eight hundred and ninety-two, providing that animals shall not be moved out of the Metropolitan Cattle Market but shall be slaughtered within the

Market is hereby revoked.

3. Nothing in this Order shall interfere with the institution or prosecution of any proceeding in respect of any offence committed against or any penalty incurred under the said Temporary Order of 1892 or the said Order hereby revoked before the commencement of this Order.

(2.) No animals shall be moved into any of the l

said lairs or premises until an Inspector of the Board of Agriculture has certified in writing that such lairs or premises have been cleansed and disinfected to his satisfaction.

(3.) If any animal is moved into any of the said lairs or premises in contravention of this Order, the occupier of such lair or premises, and the owner of the animal, and the person for the time being in charge thereof, and the person moving, directing, or permitting the movement, and the consignee or other person receiving or keeping the animal knowing it to have been moved in contravention as aforesaid, shall, each according to and in respect of his own acts or defaults, be deemed guilty of an offence against the Contagious Diseases (Animals) Act, 1878.

2. Article 40 (Disinfection for Foot-and-Mouth Disease) of the Animals Order of 1886 and any Regulation made by the Local Authority for the County of London under Article 111 (Regulations of Local Authority as to Disinfection of Places and Things) or Article 115 (Regulations of Local Authority as to Cleansing and Disinfection of Markets &c.) of the said Animals Order of 1886 shall not apply to the lairs or premises described in the Schedule to this Order until the same have been cleansed and disinfected in accordance with this Order.

3. Words in this Order have the same meaning

as in the Animals Order of 1886.

4. This Order shall commence and take effect from and immediately after the twentieth day of February, one thousand eight hundred and ninety-two.
