"Now, therefore, with the consent of the Right Reverend John Bishop of the said diocese of Salisbury as such Bishop with the consents of Henry Blathwayt Festing of number 36 Baron's Court-road, West Kensington, in the county of Middlesex Esquire, and of Norcliffe Gilpin of number nine Eaton-gardens West Brighton in the county of Sussex a Captain in Your Majesty's Army, as the patrons of the vicarage of the said parish of Wilcot, with the consent of Sir Henry Bruce Meux of Dauntsey House Chippenham in the said county of Wilts, Baronet as the patron of the vicarage of the said parish of Overton with the chapelry of Alton Priors with the consents of Horatio Nelson Goddard of Clyffe Manor, Wootton Bassett, in the said county of Wilts Esquire of Ambrose Lethbridge Goddard of the Lawn Swindon in the last-named county Esquire of the Most Honourable Henry Charles Keith Marquess of Lansdowne Viceroy and Governor-General of India of the Right Honourable Lord Charles William Brudenell Bruce of number seventy-seven Pall Mall in the said county of Middlesex a Member of Your Majesty's Most Honourable Privy Council of Clement Walker Heneage V.C. of Compton Bassett in the said county of Wilts formerly a Major in Your Majesty's Army of George Thomas John Sotherton-Estcourt, Tetbury, in the county of Gloucester, Esquire, of Lord Henry Augustus Brudenell Bruce of number thirty-six Eaton-place in the said county of Middlesex, a Member of the Commons House of Parliament, of Sir Francis Burdett of Ramsbury Manor, Ramsbury in the said county of Wilts Baronet of Francis William Leyborne Popham of Littlecote, Ramsbury aforesaid Esquire and of Fitzroy Pleyell Goddard of the Lawn Swindon aforesaid Esquire as the Trustees of Somerset Hospital, Froxfield, in the said county of Wilts, and as such Trustees, the patrons of the rectory of the said parish of Huish, and with the consent of the Right Honourable George Robert Charles, Earl of Pembroke and Montgomery as the patron of the vicarage of the parish of North Newton otherwise Newington aforesaid (in testimony whereof they the said consenting parties have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Wilcot, of the said chapelry of Alton Priors in the said parish of Overton, of the said parish of Huish, and of the parish of North Newton otherwise Newington aforesaid which portions are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of the Holy Trinity situate at Oare as aforesaid and that the same should be named 'The Consolidated Chapelry of the Holy Trinity Oare.'

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your royal consideration, and to make such Order in respect thereto as to Your Majesty in Your royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

The Consolidated Chapelry of the Holy Trinity Oare, being:—

"All those several contiguous portions of the parish of Wilcot of the chapelry of Alton Priors in the parish of Overton (detached) of the parish of Huish (detached) and of the parish of North Newton otherwise Newington (detached) all in the county of Wilts and in the diocese of Salisbury which said contiguous portions are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the parish of Pewsey, in the same county and diocese from the parish of Wilcot aforesaid, at the junction of the High-road which leads from Marlborough to Wilcot with the road which leads from Pewsey towards Draycot Farm and extending thence first north-westward and then northward along the middle of the last-mentioned road for a distance of seventy-two and a half chains or thereabouts (thereby including a detached portion of the chapelry of Alton Priors aforesaid) to the junction of the said last-mentioned road, with the road which leads from Oare to Alton Priors, and with the private road called or known as Draycot-avenue and extending thence northward along the middle of the said private road for a distance of seven and a half chains to the point to the east of Draycot Farm aforesaid where the same private road bends sharply to the west and is joined by the footpath which leads to Huish and extending thence still northward along the middle of the last-mentioned footpath for a distance of ten chains or thereabouts to the boundary which divides the said parish of Wilcot from the parish of Huish aforesaid and extending thence first northward, then generally eastward, and then again northward along the last-mentioned boundary for a distance of two miles and eighteen chains or thereabouts to the point at the road which leads from the house called or known as Huish Hill Barn towards Marlborough where the same boundary meets the boundary which divides the said parish of Wilcot from the parish of Overton aforesaid and extending thence eastward along the last-mentioned boundary for a distance of fifty-two chains or thereabouts to the point where it touches the northern side of the road leading from Oare to Marlborough and joins the boundary which divides the said parish of Overton from the detached portion of the parish of North Newton otherwise Newington aforesaid and extending thence north-eastward along the last-mentioned boundary for a distance of fifty-five and a half chains or thereabouts (thereby passing in one part a little to the west of the last-mentioned road and in another part following the south-eastern side of the same road) to the point in the road which leads from Marlborough to Milton where such last-mentioned boundary joins the boundary which divides the said detached portion of the parish of North Newton otherwise Newington from the parish of Preshute in the county and diocese aforesaid, and extending thence south-eastward for a distance of twenty chains or thereabouts (thereby following the north-eastern side of the last-mentioned road) to the point upon the same side of the same road at or near to the northern end of Clench Common where the same road is joined by the footpath leading to Rainscombe Hill Farm-house and where the said last-mentioned boundary joins the boundary which divides the said detached portion of the parish of North Newton otherwise Newington from the parish of Milton Lilbourne in the county and diocese aforesaid and extending thence southward along the last-men-
