## (FOOT-AND-MOUTH DISEASE.) By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

- 1. The limits of the following Place which is declared by order of the Local Authority of the borough of Folkestone dated the twenty-sixth day of February, one thousand eight hundred and ninety-two, to be a Place infected with foot-andmouth disease (namely),—the cow-sheds, buildings, and premises known as Park Farm, in the occupation of Mr. John Alfred Gambrill, and the several fields belonging to the said Farm known as Big Moat Meadow, Little Moat Meadow, Front Meadow, Hay Meadow, and Back Meadow,—are hereby extended so as to include the Place described in the Schedule to this Order, and the Place described in the Schedule to this Order is hereby declared to be a Place infected with foot-and-mouth disease.
- 2. This Order shall take effect from and immediately after this eighth day of April, one thousand eight hundred and ninety-two.
