(FOOT-AND-MOUTH DISEASE.) By the Board of Agriculture.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Board of Agriculture Act, 1889, and the Contagious Diseases (Animals) Acts, 1878 to 1890, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as

1. The limits of the following Area which is declared by Order of the Board dated the twelfth day of April, one thousand eight hundred and ninety-two, to be an Area infected with foot-andmouth disease (namely),—in the county of Kent included within a boundary line commencing at a point where the Sheerness and Maidstone-road crosses the Chatham and Dover-road at Key Street, proceeding thence in a south-westerly direc tion along the Sheerness and Maidstone-road to Stockbury Valley, thence in a south-easterly and easterly direction along the road leading to Bicknor, Wormshill, Frinstead, Torry-hill, and Doddington, to the junction therewith of the road leading to Linstead, thence in a northerly direction along the last-mentioned road and through Linstead to the junction of the same with the Chatham and Dover-road between Bapchild and Green-street, thence in a westerly direction along the Chatham and Dover-road through Sittingbourne to the point of commencement at Key Street above-mentioned; the said roads, hereinbefore described as the boundary line, not being included in the Area,—are hereby extended so as to include the Area described in the Schedule to this Order and the Area described in the Schedule to this Order shall for the purposes of the said first-mentioned Order be deemed to be the Area described in the Schedule to that Order, and, as
