junction with the eastern end of a certain proposed road intended to be called Seymour-road and extending thence westward along the middle of the intended course of the said proposed road for a distance of twenty-two and a quarter chains or thereabouts (thereby crossing the boundary which divides the said new parish of Saint Ann Hanger-lane from the parish of Hornsey aforesaid) to the point where the western end of the said proposed road joins Wightman-road and extending thence westward and in a straight line across the last-named road to the eastern end of the wall or fence which divides the house and premises numbered one hundred and fifty-seven Wightman-road and situate upon the western side of that road from the house and premises numbered one hundred and fifty-five Wightman-road and also situate upon the western side of the same road and extending thence south-westward along the said wall or fence for a distance of thirty-nine yards or thereabouts to its western end and continuing thence in precisely the same direction and in a straight line for a further distance of eightythree yards or thereabouts to a point in the middle of the main line of the Great Northern Railway upon the boundary which divides the said parish of Hornsey from the new parish of the Holy Innocents Hornsey in the county and diocese aforesaid and extending thence first south-eastward and then southward along the middle of the said line of railway for a distance of thirty-four chains (thereby following for a distance of two chains or thereabouts the last-mentioned boundary and for a distance of thirty-two chains or thereabouts the boundary which divides the said parish of Hornsey from the new parish of the Holy Trinity Stroud Green aforesaid) to the point at the centre of the bridge which carries the same line of railway over the line of the Midland Railway where the said last-mentioned boundary bends sharply towards the east along the last-named line of railway and extending thence that is from the last described point southward along the middle of the main line of the Great Northern Railway aforesaid for a distance of eight chains or thereabouts to a point upon the boundary which divides the said new parish of the Holy Trinity Stroud Green from the above-mentioned isolated portion of the said parish of Hornsey and extending north-eastward along the last-mentioned boundary for a distance of twenty-two and a half chains or thereabouts (thereby following for the most part the said boundary fence of Finsbury Park upon the southern side of Endymion-road as aforesaid) to the firstly-mentioned point where the said lastmentioned boundary meets the boundary which divides the said new parish of the Holy Trinity Stroud Green from the new parish of Saint Ann Hanger-lane aforesaid at which point the said imaginary line commenced."

And whereas the said representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London. W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy; of the Act of the fourteenth and fifteenth years of Her Majesty, chapter ninety-seven; of the Act of the nineteenth and twentieth years of Her Majesty, chapter fiftyfive; and of the Act of the thirty-fourth and thirty-fifth years of Her Majesty, chapter eightytwo; duly prepared and laid before Her Majesty in Council a representation, bearing date the twelfth day of May, in the year one thousand eight hundred and ninety-two, in the words and figures following; that is to say :--

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of Your Majesty, chapter seventy, of the Act of the fourteenth and fifteenth years of Your Majesty, chapter ninety-seven, of the Act of the nineteenth and twentieth years of Your Majesty chapter fifty-five, and of the Act of the thirty-fourth and thirty-fifth years of Your Majesty chapter eighty-two, have prepared, and now humbly lay before Your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Jude, Shieldfield situate within the limits of the new parish (sometime district chapelry) of Christ Church, Shieldfield in the city and county of the city of Newcastle-upon-Tyne and in the diocese of Newcastle.

"Whereas at certain extremities of the said new parish of Christ Church, Shieldfield, and of the new parish (sometime particular district) of Jesmond, in the city, county and diocese aforesaid which said extremities lie contiguous one to another, and are described in the schedule hereunder written there is collected together a population which is situate at a distance from the several churches of such new parishes respectively.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said new parish of Christ Church Shieldfield, and of the new parish of Jesmond aforesaid, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Jude Shieldfield situate as aforesaid.

"Now therefore, with the consent of the Right Reverend Ernest Roland, Bishop of the said diocese of Newcastle, as such Bishop and also as the patron in right of his see of the vicarage of the said new parish of Christ Church Shieldfield (in testimony whereof he the said Bishop has signed this representation and caused his episcopal seal to be set thereto) and with the consents of Joseph Grey of Low Fell Gateshead in the county of Durham, Timber Merchant; of Hugh Lee Pattinson of No. 136, Fellows-road, London N.W. Esquire ; of Robert Gurney Hoare of Newcastle-upon-Tyne aforesaid, Banker; of Abel Henry Chapman of Low Fell Gateshead aforesaid, Engineer; and of the Very Reverend William Lefroy Doctor in Divinity, Dean of the cathedral church of Norwich (in testimony whereof they the said last-named consenting parties have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent, that it would in our opinion, be expedient that all those
