"That the said district (hereinafter called The District Number 1) contains sixty-six houses most of which are more than one mile from the parish church of Upton Saint Leonards and less than one mile from the parish church of Matson while the nearest parts of the said District Number 1 are within twenty yards of the parish church of Matson and the furthest point is within a mile of the same church.

"That the population of the said District Number 1 amounts to about three hundred persons who can more conveniently attend for Divine worship the parish church of Matson than the parish church of Upton Saint Leonards.

"That the said parish church of Matson is capable of affording accommodation to the inhabitants of the said District Number 1 as well as the parishioners of Matson.

"That the said parish of Matson the population of which parish is seventy-three, comprises two districts (hereinafter called District Number 2 and District Number 3).

"That the said District Number 2 is bounded on all sides by the parish of Upton Saint Leonards and which district consists of several pieces of land and hereditaments containing altogether thirty-eight acres one rood and more particularly delineated on the map Number 2 hereunto annexed and thereon coloured pink.

"That the said District Number 2 contains one cottage and part of a cottage inhabited by ten persons which cottages are distant one mile or thereabouts from the parish church of Matson and not more than half a mile from the parish church of Upton Saint Leonards.

"That the inhabitants of the said District Number 2 can more conveniently attend for Divine worship the parish church of Upton Saint Leonards than the parish church of Matson.

"That the said parish church of Upton Saint Leonards is capable of affording accommodation

to the inhabitants of the said District Number 2 as well as the parishioners of Upton Saint Leonards.

"That the said District Number 3 is bounded on the north by Prinknash Park on the east by the parishes of Cranham and Painswick and on the west by the parish of Upton Saint Leonards and consists of a piece of land called Pope's Wood containing sixty acres one rood and fifteen perches and is more particularly delineated on the map Number 3 hereunto annexed and thereon coloured pink.

"That the said District Number 3 contains a cottage inhabited by three persons which cottage is distant two miles and a half from the parish church of Matson and one mile a half or thereabouts from the parish church of Upton Saint Leonards.

"That the patronage of the said rectory and parish church of Upton Saint Leonards belongs to me Charles John, Bishop of Gloucester and Bristol and the patronage of the said rectory and parish church of Matson belongs to the Dean and Chapter of the Cathedral Church of Gloucester.

"That the Reverend Edward Chessall Scobell M.A. is the present rector of the said rectory of Upton Saint Leonards and the Reverend William Bazeley M.A. is the present rector of the said rectory of Matson.

"That it appears to me that under the provisions of the Pluralities Act 1838 (1st and 2nd Victoria c. 106) the following alterations may be advantageously made namely:—

"1. That the District Number 1 belonging to the said parish of Upton Saint Leonards may be separated from the residue of the said parish and be united to the said parish of Matson for ecclesiastical purposes.

"2. That the said Districts Numbers 2 and 3 belonging to the said parish of Matson may be separated from the residue of the said parish and
