THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Notice, dated 14th July, 1892, from Her Majesty's Representative at Malta, whereby the following are substituted for paragraphs 4 and 9 of the Notice issued on the 12th instant:—

4. Vessels arriving direct from Adalia and Jaffa and from the coast of Turkey in Asia between those ports are to undergo 10 days' quarantine. Vessels arriving from the above places but which have been admitted to pratique at intermediate ports, are to be admitted to pratique in these Islands.

Vessels arriving from the Russian coast in the Black Sea, from Sukumkaleh to Batoum inclusively, are to undergo 7 days' quarantine.

Vessels arriving from other parts of the Black Sea coast, including the coast of the Sea of Azov, are to undergo 24 hours' observation in the Great Harbour.

9. The importation of susceptible goods as

hereunder specified from any of the ports subjected to quarantine is prohibited, viz.:—

Rags, cotton and cotton seed, raw silk, hair, and feathers.

Other susceptible goods arriving from any of the ports subjected to quarantine are to be thoroughly disinfected.

"Bucharest, July 22, 1892.—My telegram of 20th instant. Arrivals from Russian ports on Danube wishing to touch at Roumanian Danubian ports must undergo five days' quarantine at Sulina. Vessels proceeding from Sulina up stream and those proceeding from Braila, Galatz, and Toulcha to Sulina have to take on board Sanitary Officer, who will see that these vessels do not touch at Russian coast."
