Fixed Light on Granite Island.

THE Government of South Australia has given notice, that on 1st June, 1892, a light would be exhibited on the east end of Granite Island, south side of entrance to Port Victor :-

Granite Island Light is a fixed white light, visible through an arc of 152°, or from the bearing of N. 31° E. (leading eastward of West Island), through west, to S. 59° W. (leading southward of Pullen's Island), and should be seen in clear weather from a distance of ten miles.

Kilimán River Entrance-Shoal Patch within the Bar.

INFORMATION has been received from the Naval Commander-in-Chief on the Cape of Good Hope Station, of the existence of a shoal patch, with seven feet on it at low water (bottom fine sand), lying within the bar, Kilimán River Entrance, with Tangalane Point Lighthouse bearing N. 15° E., distant 2° miles, and Ponta Olinda N. 22° W.

Misima Nada-Shoal near Track Recommended.

THE United States Government has given notice, dated 25th June, 1892, that the Commander of the United States ship "Alert" reports that when following the "Track through " Misima Nada (as shown on Admiralty Chart, No. 83), a sounding of seven fathoms was obtained near where 25 fathoms or more has heretofore been charted, with the south end of Koai Sima bearing W. ²/₈ S., and the south-west point of Itsuki Sima N. by W. $\frac{1}{2}$ W., distant $3\frac{1}{10}$ miles. The ship's course was then altered to N. by W. W., and for a distance of about eight cables, depths of seven fathoms were found, the water then deepening to 15 fathoms.

Approximate position of south end of shoal, lat. 34° 3' 55" N., long. 132° 48' 20" E.
