"The SCHEDULE to which the foregoing representation has reference.

"The District Chapelry of Saint Andrew Woodside being:

"All that part of the parish of Caddington situate partly in the county of Bedford and partly , in the county of Hertford and wholly in the diocese of Ely which is bounded upon the northeast and upon the east by the parish of Luton in the said county of Bedford and in the diocese of Ely aforesaid upon the south-east by the parish of Flamstead in the said county of Hertford and in the diocese of Saint Albans upon part of the south-west by the new parish of Saint John Markyate Street situate partly in the said county of Hertford and partly in the said county of Bedford and wholly in the diocese of Saint Albans aforesaid and upon the remaining sides that is to say upon the remaining part of the south-west and upon the north-west by an imaginary line, commencing upon the boundary which divides the said new parish of Saint John Markyate Street from the parish of Caddington aforesaid at the point in the middle of the road called or known as the Slip End and Markyate Street road which leads from Saint John's Church Markyate Street to Slip End and Luton where the said boundary bends sharply towards the southwest and leaving the said county boundary begins to follow the middle of the said road and extending thence that is to say from the said point north-westward along the said county boundary for a distance of thirty-one and a half chains or thereabouts thereby crossing near the Harrow Inn the road called or known as the Woodside and Markyate Street road which leads past the house called or known as Woodside Farm, to Luton, to a point exactly one hundred yards measured in a straight line to the north-west of the middle of the last-mentioned road, and extending thence north-eastward in a course distant exactly one hundred yards to the north-west of and parallel to the middle of the same road for a distance of forty chains or thereabouts to a point exactly one hundred yards to the north-west of the point where the same road bends sharply towards the north-west and is joined by the footpath which leads to the Lodge Gate forming the south-western entrance to Stockwood Park and extending thence still north-eastward in a course distant exactly one hundred yards to the north-west and parallel to the middle of the said footpath for a distance of sixteen and three quarters chains or thereabouts to a point in the middle of the road which leads from New Inn Farm along the south-western boundary of Stockwood Park aforesaid to Farley Green which point is upon the boundary which divides the said parish of Caddington from the parish of Luton aforesaid."

And whereas the said representation has been approved by Her Majesty in Council: Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said C. L. Peel. diocese of Ely.

The QUEEN's Most Excellent Majesty in Council.

TATHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-eighth day of July, in the year one thousand eight hundred and ninety-

two, in the words following, that is to say;
"We the Ecclesiastical Commissioners for
England in pursuance of the Act of the sixth and seventh years of Your Majesty chapter thirtyseven have prepared and now humbly lay before Your Majesty in Council the following scheme for constituting a separate district for spiritual purposes to be taken partly out of the parish of Cheriton in the county of Kent and in the diocese of Canterbury, and partly out of the parish of Folkestone in the same county and diocese.

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular portions of the said parish of Cheriton and of the said parish of Folkestone which are hereinafter mentioned and described should be constituted a separate district in manner hereinafter set forth.

"And whereas there is not at present within the limits of the said proposed separate district any consecrated church or chapel in use for the

purposes of Divine worship.

"And whereas in conformity with the terms of the will of the late Mrs. Catherine Thompson of Seabrook Vale in the said parish of Cheriton, Widow, William Henry Dowling Reeves Welman, Companion of the Most Honourable Order of the Bath, a Major-General on the Retired List of Your Majesty's Army, and George Wilks, of Hythe in the said county of Kent Solicitor, the trustees of the said will have contributed and paid to the credit of our account at the Bank of England a sum of eleven thousand three hundred and eighty-seven pounds nineteen shillings and five pence upon trust to apply a portion of the said sum amounting to five thousand pounds sterling, with certain accumulations of interest thereon as and for the endowment of the district hereinafter recommended to be constituted, and (so soon as the said district shall have become a new parish under the provisions of the hereinbefore mentioned Act) then of the said new parish and of the maintenance of the minister or incumbent thereof for the time being, and we have in respect of such sum agreed and have undertaken to provide and pay by equal half-yearly payments on the first day of May and the first day of November in each and every year to such minister or incumbent as aforesaid when duly licensed in accordance with the provisions of the last-mentioned Act a sum which will amount to not less than one hundred and fifty pounds per annum.

"And whereas it is intended that the balance of the said sum of eleven thousand three hundred and eighty-seven pounds nineteen shillings and five pence shall be applied by us in certain proportions towards providing a church for the said district and new parish and a house of residence

for the minister or incumbent thereof.

"And whereas the said sum of eleven thousand three hundred and eighty-seven pounds nineteen shillings and five pence has been contributed and paid as aforesaid upon the understanding and condition that (such arrangement appearing to us
