to be expedient) we should recommend and propose to Your Majesty in Council that the whole right of patronage of the said district or new parish and of the nomination of the minister or incumbent thereof should be assigned in the manner hereinafter set forth.

"And whereas the said William Henry Dowling Reeves Welman and the said George Wilks have nominated to us the Right Honourable and Most Reverend Edward White Archbishop of the said diocese of Canterbury as the person to whom they desire that the first turn of patronage and appointment of the minister or incumbent of the said proposed district or new parish should be assigned and the Reverend William Blackwall Buckwell Clerk in Holy Orders the present rector of the said parish of Cheriton and his successors rectors of the same parish for ever as the persons to whom the second and every succeeding turn of patronage and presentation should be assigned.

"Now therefore with the consent of the said Edward White, Archbishop of the said diocese of Canterbury (in testimony whereof he has signed and sealed this scheme) we the said Ecclesiastical Commissioners humbly recommend and propose that all those portions of the said parish of Cheriton and of the said parish of Folkestone which are described in the schedule hereunder written all which portions together with the boundaries thereof are delineated and set forth on the map or plan hereunto annexed, shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme become and be constituted a separate district for spiritual purposes and that the same shall be named 'The District of All Souls Cheriton-street' and shall be endowed as aforesaid.

"And we further recommend and propose that the right of patronage of the said district so recommended to be constituted and (when such district shall have become a new parish as aforesaid) then of the said new parish and of the nomination of the minister or incumbent thereof shall without any assurance in the law other than this scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid be assigned to and be absolutely vested in and shall and may be exercised for the first turn by the said Edward White Archbishop of the said diocese of Canterbury and that the second and every succeeding turn of patronage and nomination shall be assigned to and be absolutely vested in and shall and may from time to time be exercised by the said William Blackwall Buckwell Rector of the said parish of Cheriton and his successors rectors of the same parish for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Act or any of them or of any other Act of Parliament. "The SCHEDULE to which the foregoing

scheme has reference.

" The District of All Souls, Cheriton-street, being :----

"All those contiguous portions of the parish of Cheriton and of the parish of Folkestone both in the county of Kent and in the diocese of Canterbury wherein the present incumbent of each such parish still possesses the exclusive cure of souls, all which said portions are comprised within and are bounded by an imaginary line commencing

upon the boundary which divides the new parish of Sandgate in the county and diocese aforesaid, from the said parish of Folkestone at the middle of the southern end of the bridge situate four and a half chains or thereabouts to the east of the eastern end of Shorneliffe Railway Station, which bridge carries the line of the South Eastern Railway over the road which leads directly to the southern end of Broadmead-lane, and extending thence northward along the middle of the said road for a distance of nine chains or thereabouts to the point where it joins the said Broadmead-lane and also the road leading from Folkestone to Cheriton-street and Newington and extending thence first northward, then north-westward, then north-eastward, and then again northward along the middle of the said lane for a distance of one mile and twentyone chains or thereabouts to a point on the northern side of Cæsar's Camp at the junction of the same lane with the roadway which leads from Coombe-lane and the Canterbury-road to Newington upon the municipal boundary of the borough of Folkestone and extending thence generally westward along the said municipal boundary for a distance of fifty-three chains or thereabouts thereby following the course of the last described roadway to the point where the same municipal boundary joins the boundary which divides the said parish of Folkestone from the parish of Cheriton aforesaid and extending thence still westward along the last-mentioned parish boundary for a distance of three chains or thereabouts. (thereby following the middle of the said last described roadway) to the point where the said last-mentioned parish boundary meets the boundary which divides the said parish of Cheriton from the parish of Newington near Hythe in the county and diocese aforesaid, at the junction of the said last described roadway with the road or footpath which leads from Dane Farm into Wood-lane, and extending thence first south-westward and then southward along the last described road or footpath for a distance of fifty chains or thereabouts to its junction with Wood-lane aforesaid and continuing thence still southward along the middle of the last-named lane for a distance of thirty chains or thereabouts to the junction of the same lane with the above-mentioned road which leads from Newington aforesaid through Cheriton-street to Folkestone and extending thence eastward along the middle of the last described road for a distance of two chains or thereabouts to its junction with the public foot-path leading to Risborough and to Cheriton parish church and extending thence southward along the middle of the last-mentioned footpath for a distance of six and a half chains or thereabouts to the middle of the footbridge which carries the same footpath over the line of the South Eastern Railway aforesaid and extending thence eastward along the middle of the said line of railway for a distance of forty-five chains or thereabouts to the boundary which divides the said parish of Cheriton from the parish of Folkestone aforesaid and extending thence southward along the last-mentioned boundary for a distance of thirty yards or thereabouts to its junction on the southern side of the said line of railway with the boundary which divides the said new parish of Sandgate from the parish of Folkestone aforesaid, and extending thence eastward along the last-mentioned boundary for a distance of thirty-four chains or thereabouts (thereby following the southern side of the said line of railway) to the firstly-mentioned point at the southern end of the
