THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 17th August, 1892, from Her Majesty's Representative at Vienna, enclosing the following Translation of a Circular issued by the Austro-Hungarian Maritime Board:—

No. 7450.

By Order in Council, dated August 8, both by the Minister for Commerce and Exchequer in order to avoid the danger of the cholera being introduced into the country, the Austrian Government agreeing with the Hungarian Government have prohibited the import from Russia of fruit, greens, and vegetables, and also of caviar and fish, fresh, dried, smoked, or salted, and of skins of animals and other animal produce. This Order enters into force the day it reaches the I. R. Custom House and Health Officers.

When any of the above things arrive in Austrian ports, be it on board Austro-Hungarian or foreign vessels, they are to be sent to the nearest lazaretto at the expense of the skipper for re-exportation within a very short time, at the end of which the things will be destroyed.
