THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 29th August, 1892, from Her Majesty's Representative at Constantinople, transmitting a Notice issued by the Porte relating to quarantine. The following translation is a résumé of the same :—

Constantinople, August 24, 1892.

Sailing ships coming from the infected part of the Black Sea shall proceed to Sinope to perform their quarantine.

Sailing ships, if they find it impossible to proceed to Sinope, and can prove by certificate of the Port Authorities a case of force majeure, may perform their quarantine at Buyouk-Liman.

Transit of the Straits of the Bosphorus is forbidden to sailing ships.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 31st August, 1892, from Her Majesty's Representative at Vienna, enclosing the following Circulars relating to quarantine :—

By Order in Council, dated the 29th of August, the Ministries for Home Affairs, Finance, and Commerce, agreeing with the Hungarian Government, and in order to avoid the danger of cholera being imported, prohibits the introduction from Hamburg and Altona of rags, old clothes, old ropes, old linen; also of fruit, vegetables, and greens; and of fish not in tins, and of raw animal produce.

This measure comes into force from the day it reaches the Custom-house and port officers.

Should any vessels arrive with any of the above-mentioned things on board, they are to be sent to the nearest lazaretto at the expense of the shipper, to be re-exported within a very short time, and if not done they will be destroyed.

OFFICIAL news having proved the outbreak of cholera at Hamburg, Altona, and Kronstadt, arrivals from the mouths of the Elbe and from the Russian ports in the Baltic will be subjected to a quarantine reserve of seven days.

Wearing apparel will be disinfected according to the prescribed regulations.

This measure applies to vessels that have had a clean passage and arrive in healthy conditions, for in cases of sickness on board the Marine Board will decide on the measures to be taken.

These measures apply to vessels that have had a clean passage and arrive in perfectly healthy conditions. Should this not be the case, the Marine Board will decide what measures are to be taken.
