THE Queen has been pleased to grant unto Frederick Dixon Dixon-Hartland, of Ashley Manor, in the county of Gloucester, Esquire, Representative in Parliament for the Uxbridge Division of the County of Middlesex, one of the Commissioners for executing the Lieutenancy in and for the City of London, and in the Commission of the Peace for the counties of London, Middlesex, Worcester, and Gloucester, eldest son of Nathaniel Hartland, late of the Oaklands, in the parish of Charlton Kings, in the said county of Gloucester, by Eliza, his wife, daughter and coheir of Thomas Dixon, late of King's Lynn, in the county of Norfolk, Esquire, all deceased, Her Royal licence and authority that he may continue to use and bear the surname of Dixon in addition to and before that of Hartland, and that he may bear the arms of Dixon quarterly with those of his paternal family, and that such surname and arms may in like manner be taken, borne, and used by his issue; the said arms being first duly exemplified according to the laws of arms and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And also to command that the said Royal concession and declaration be recorded in Her Majesty's College of Arms.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 4th September, 1892, from Her Majesty's Representative at San Sebastian, enclosing the following Royal Order, relating to quarantine:—

Colonial Ministry.—Royal Order.

Arrivals from the foreign ports, Hamburg, Havre, and Antwerp, being declared infected, with reference to the provisions of the existing law of health, as enacted in the Royal Orders issued by the Ministry of the Interior on the 23rd, 26th, and 27th instant, and published in the Gazettes of the 24th, 27th, and 28th instant, and taking into account that the mail steamers of the Transatlantic Company touch, according to their itineraries, at the abovenamed ports, which tends to endanger the public health on their arrival in the peninsula, when sailing to the Antilles or the Philippines, and which as a precautionary measure should be avoided henceforward:—

The King (whom God preserve), &c., has ordained that the necessity of touching at the abovenamed ports by the mail steamers of the said Company shall be suspended, extending this suspension to the port of Marseilles and to all ports from which arrivals may henceforth be declared by the Ministry of the Interior to be infected.
