THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram, dated 9th September, 1892, from Her Majesty's Representative at Alexandria, stating that the Jemen coast of the Red Sea from Hodeida to Lith, latter port not included, has been placed in quarantine by the Egyptian authorities.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated 7th September, 1892, from Her Majesty's Representative at Rotterdam, reporting that the latest official communication with reference to the arrival at the outports of vessels from places infected with cholera, states that:—

“Provided no symptoms of illness have been detected in any members of the crew during the previous four days, and that the bedding, bilge-water, and linen effects have been disinfected, and new bilge-water and fresh water for consumption have been taken on board, vessels will be allowed to proceed to their destination. The charges for disinfecting each vessel amount to 16s. 8d.

In all cases therefore where the voyage is of shorter duration than four days, ships will be detained in quarantine until the full expiration of the four days after departure from the infected port.

THE Board of Trade have received, through the Secretary of State for the Colonies, a copy of the following Telegram, dated 9th September, 1892, from Her Majesty's Representative at Cyprus:—“Five days' quarantine on arrivals from London, Liverpool, Shields, Grimsby, Glasgow, and Swansea, ten days on coast from Cronstadt to Cherbourg, five days on Mediterranean ports of France, Italy, and Austria, ten days on Kurrachi and every Persian port in Persian Gulf, ten days on Yemen, and every port from Guardafui to Massowa.”

Circular No. 8232.

The prohibition of importation or transit of rags from Hamburg, Altona, and all other German ports of the North Sea introduced by Circulars of the 29th of August and of the 2nd of September, is hereby extended to all the German Empire under the same restrictions of re-exportation as before.

THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated the 8th September, 1892, from Her Majesty's Representative at Bucharest, stating that the Roumanian Government have, by circular, forbidden the importation from Germany, Belgium, or Austria-Hungary, of the following articles, viz.:—

- (a.) Body and bed linen, as articles of commerce, used but not washed.
- (b.) Worn clothing, drills, remainders of woven stuffs, and paper scrapings.
- (c.) Raw hides, unwashed wool and wadding.
- (d.) Milk, butter, cheese, and fruits.

The Roumanian Government have also closed the whole of the frontier of the Bucovina to travellers and goods, except Burdujeni.
