(4.) Any Joint Committee consisting of representatives of two or more of the said County Councils, or of representatives of one or more of the said County Councils and of other persons not being representatives of any other County Council.

(5.) Such of the Visiting Committees of Asylums or other Joint Committees including representatives of the County Council of one or more of the said Counties and representatives of the County Council or Councils of some other County or Counties, as We may by Order under Our Scal hereafter prescribe.

ARTICLE II .- It shall, unless We otherwise Prescrib, be the duty of the said District Auditor to audit the Accounts of the following Authorities and of their Officers; namely,-

(1.) The Guardians of the Poor of the several Unions named in Schedule B to this Order.

(2.) The Overseers of the Poor of the several Parishes comprised in the said Unions.

- (3.) The several other Authorities for the time being whose Accounts are or may be by law subject to be audited by a District Auditor, and whose Districts or the areas of whose jurisdiction are for the time being wholly situated within one or more of the said Unions.
- (4.) Such of the other Authorities whose Accounts are or may be by law subject to be so audited, and whose Districts or the areas of whose jurisdiction are for the time being partly situated within one or more of the said Unions, as We may by Order under Our Seal hereafter prescribe.

ARTICLE III.—The said District Auditor shall audit the said Accounts according to the provisions of the several Statutes and of the Orders issued by competent authority, in force for the time being in that behalf, and shall perform all such duties and exercise all such powers in connection with the audit of such Accounts as are prescribed and conferred by the said Statutes and O. ders.

ARTICLE IV.—The District in which the said Thomas Howel Kyffin Roberts shall act as Auditor, and which shall be termed the "Eastern and Midland Counties Audit Listrict," shall, for the performance of the duties assigned to him by Article I of this Order, comprise the area for the time being included in the several Administrative Counties named in Schedule A to this Order, and the area comprised in the Kent and Essex Sea Fisheries District; and, for the performance of the duties assigned to him by Article II of this Order, shall comprise the area for the time being included in the several Unions named in Schedule B to this Order, and the Districts or areas subject to the jurisdiction of any such Authority as is mentioned in paragraph (4) of the said Article II.

ARTICLE V .- Any Order in force at the date of this Order assigning a District to the said Thomas Howel Kythn Roberts for the discharge of his duties as District Auditor is hereby rescinded, but nothing in this Order shall affect or interfere with the duties and powers of the said Thomas Howel Kyffin Roberts, or of any Assistant District Auditor, as regards any Audit which, before the issue of this Order, may have been commenced or held by either of them, or of which either of them may have given notice, or as regards any proceedings atising out of any such Audit.

ARTICLE VI.—In this Order-

The term "Union" includes any union of Parishes incorporated or united for the relief or maintenance of the Poor under any Act of Parliament, and any Parish for which there is a separate Board of Guardians.

The term "Parish" includes any place for which a separate Poor Rate is or can be made or for which a separate Overseer is or

can be appointed.

The term "Guardians" includes any Governors, Directors, Acting Guardians, Vestrymen, or other Officers appointed or entitled to act in the distribution or ordering of relief to the Poor from the Poor Rates under any Act of Parliament.

The term "Overseers of the Poor" include s Churchwardens and Assistant Overseers.
